AND WHEREAS it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

- 1) The SETTLOR above named hereby establishes a Public Charitable Trust by the name of CANCER AWARENESS, PREVENTION AND EARLY DETECTION TRUST for the purpose and upon the conditions set forth hereunder
- 2) The TRUSTEES named above shall be the first trustees and have given their consent to be appointed as the trustees and as token thereof, they have set their hands to this instrument.
- 3) The SETTLOR hereby conveys, transfers and assigns to the TRUSTEES the above referred sum of Rs. 10,000/- (Rupees ten thousand only) as corpus to the TRUST, the receipt of which, the TRUSTEES do hereby admit and acknowledge

4) The **SETTLOR** of the Trust hereby conveys, transfers, assigns to the **TRUSTEES** the assets and properties mentioned in the Schedule hereunder, the possession of which the Trustees hereby admit and acknowledge, to have and to hold the same in trust as corpus of the Trust, to be used by the Trustees to carry out and fulfill the objects of the Trust set forth herein, and the **SETTLOR** of the Trust hereby relinquishes for all time any claim to or interest in the said assets and properties or fund forming the subject matter of the Trust.

5) The office of the Trust for the time being shall be at Escape 271, Nirvana Country, Sector-50, Gurgaon-122018, with the power given to the Trustees to shift the same to any other place as two thirds of the total number of trustees then in office decide by resolution in a meeting of the trustees.

6) The **TRUSTEES** do hereby agree that they shall hold and stand possessed of the said trust assets, properties and funds (which expression shall include all investments in cash or kind or in any nature whatsoever into and for which, the said property or a part or parts thereof may from time to time be converted, varied or exchanged) and/ or such investments as may be held by the **TRUSTEES** from time to time in relation to these presents together with all income, profits, additions and accretions thereof, upon trust for the object set out herein with and subject to the provisions and conditions hereinafter contained in these presents.

7) That the objects for which this trust is established are:

(a) To establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centres and/or such other similar charitable institutions in India for the benefit and use of the general public or grant medical aid to needy.

- (b) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of computers, books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.
- (d) To promote, establish, support, maintain or grant aid to institutions and individuals for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.
- (e) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharamshalas and rest houses, for use by public in general.
- (f) To promote sports/ games including contemporary sports among youth and others or to grant aid to sportsman of any sports/games.
- (g) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons and other victimized persons.
- (h) To provide platform for all performing arts, to arrange training camps and workshops by artists and experts involved in the respective forms of performing arts to create interest and motivate the younger

generation, to provide financial assistance and aid to needy artists and experts in performing arts.

- (i) To conduct or assist in conducting activities of art, music, dance, drama folklore, literature scientific and charitable nature to all or any of the objects of the Trust and for the achievement of the objects mentioned herein.
- (j) To establish and develop institutions for the physically handicapped and disabled or mentally challenged persons and to provide them education, food, clothing or other help.
- (k) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
- (l) To grant aid or render assistance to other public charitable trusts or institutions.
- (m) To undertake, carry out, promote and sponsor rural development including any programme for promoting the social and economic welfare of or the upliftment of the public in any rural area and to incur any expenditure on any programme of rural development and to assist execution and promotion thereof either directly or through an independent agency or in any other manner. In order to implement any of the above mentioned objects or purposes, transfer without consideration or at such fair or concessional value and divest the ownership of any property of the Trust to or in favour of any public or local body or authority, Central or State Government or any public institutions or Trusts.

(n) To establish provide maintain and conduct or otherwise subsidise research laboratories and experimental workshops for scientific and technical research and experiments and to undertake and carry on with all scientific and technical researches, experiments and tests of all kinds and to promote studies and research both scientific and technical, investigation and invention by providing, subsidizing, endowing of assisting laboratories, workshops, libraries, meetings, lectures and conferences and by providing for the remuneration of scientific or exhibitions scholarships, prizes and grants to students, or otherwise and generally to encourage, promote and reward studies, researches, investigations, experiments, tests and inventions of any kind.

(o) To appropriate, use or lay out land belonging to the Trust for streets, parks, pleasure grounds, allotments and other conveniences and to present any such land so laid out to the public.

(p) To dedicate, present or otherwise dispose off, either voluntarily or for value, any property of the Trust deemed to be of national, public or local interest to any national trust, public trust, public body museum, corporation or authority or any trust or on behalf of any of the same or for public.

(q) AND GENERALLY to undertake any charitable activities for public benefit without any discrimination of caste, creed, color, gender, religion, faith, race or any nationality.

8) That in case any of the objects of the Trust are held to be unlawful within the meaning of Indian Trust Act or any statutory modification(s) thereof, the trustees shall not carry out such objectives.

9) That the trust fund may be augmented by the income from the initial fund and also by donations and other contributions and income generated from assets/properties of the trust from time to time.

10) That the trust fund shall not be applied for any purpose other than those specified in para 7 to 9 hereinabove.

11) **PROPERTIES:** The Trust properties shall consists of:

(a) The amount Transferred by the **SETTLOR** as mentioned above, towards the Corpus fund of the Trust.

(b) The immovable properties and other assets transferred by **SETTLOR** as mentioned above.

(c) Any cash, kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over any property movable or immovable.

(d) All additions and accretions to the Trust properties and the income there from.

(e) All donations, gifts, legacies or grants, in cash or kind accepted by the Trustees upon Trust.

The Trust property may be utilized for the purchase of assets such as land, buildings, furniture, fittings, equipment, etc. or may be utilized for the attainment of the objects of the trust or it may be invested or deposited in accordance with the forms and modes permissible to public charitable trusts under the law for the time being in force and the income arising there from may also be utilized for any of the aforesaid purposes by the Trustees.

The income earned from the Trust property that has been set apart or accumulated in the applicable financial year shall be invested or deposited only in accordance with the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act, 1961 or of any provisions of the said Act and other law hereinafter enacted covering the investment of funds relevant to the grant of tax exemption to public charitable trusts.

The Trust may carry on a business which is incidental to the attainment of the objects of the Trust and utilize any surplus generated there from towards the furtherance of the Trust's objects and maintain separate books of account for such business activities/transactions.

12) That the trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.

13) That the trustees shall always perform their functions in accordance with provisions of Indian Trust Act or any modification thereof from time to time.

14) That for the furtherance of the objects of the trust, the trustees shall have the following powers subject to provisions under the Indian Trust Act and Income Tax Act and any modification(s) thereof:

(a) To accept, at their absolute discretion, any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.

(b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereof, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.



- (c) To convert and deal with the trust property and/or any investments for the time being.
- (d) To invest the trust fund in government securities, savings certificates, fixed deposits or in any other form of investment authorized under provisions of Indian Trust Act and Income Tax Act and any modification(s) thereof, as the trustees may deem fit from time to time.
- (e) To purchase, sell, dispose off, alienate or otherwise deal with any property comprising the trust fund.
- (f) To let out, demise any immovable property of the Trust for such period and on such rent and on such terms and conditions as the trustees in their discretion may think fit.
- (g) To open savings/current/deposit account in the name of the trust, trustees and/or institutions run/conducted by the Trust with a bank or banks, to operate such accounts and to give instructions to the bank and to provide for opening and operation of such account jointly by any two of the trustees or persons duly authorised by the trustees provided however that one signatory thereof shall always be a trustee.
- (h) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the trust fund.
- (i) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.

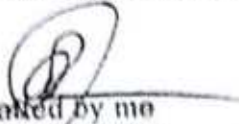

- (j) To appoint or make provision for the appointment of any person (including all or any of the trustees and committees or administrator or managing trustees or otherwise) for the purpose of the administration of the trust in such manner and subject to such rules and regulations as the trustees may prescribe and also to appoint or provide for the appointment of separate trustees to hold any fund or investment subject to the provisions of this deed in such manner and subject to such rules and regulations as the trustees may from time to time think fit.
- (k) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the trust and otherwise for giving effect to the objects of the trust.
- (l) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- (m) To set apart and/or allocate the whole or a part of the income or the corpus of the trust fund or part thereof for any of the objects of the trust.
- (n) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this trust.
- (o) To give aid by way of donations to different charitable institutions, societies, organizations or trusts in India which may have been established or which may hereafter be established for the like

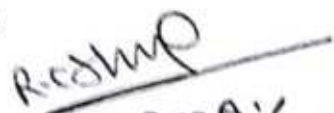
33) For the removal of doubts, it is hereby declared that, for the purpose of counting requisite strength of the Board of Trustees for any particular matter, if such requisite strength is not an absolute number then higher absolute number shall be reckoned for calculating such requisite strength.

34) It is expressly declared that no part of the trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

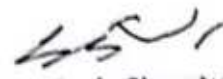
